- Establishing and maintaining performance standards which enable work to be performed safely and in compliance with Health & Safety legislation and other requirements to which the company subscribes.
- The consultation and participation of employees and contractors in all relevant Safety & Health matters.
- Continual improvement of the Health, Safety & Wellbeing management system to identify and eliminate hazards where possible and reduce OH&S risks.
- Investigating all injuries and incidents to understand all the facts, learnings and implement corrective action plans to avoid recurrence.
- Developing a positive Fair & Just safety culture encouraging employees, contractors and supply chain partners to report all incidents, near misses, hazards, risks and areas for improvement.
- Protecting workers from reprisals when reporting incidents, hazards, risks and opportunities

Our objectives are as follows:

- Produce plans that set out companywide Health, Safety & Wellbeing objectives with defined timescales and to monitor performance against those targets.
- Ensure we have sufficient competent people to achieve these objectives.
- Undertake suitable and sufficient Risk Assessments and review these as necessary.
- Develop and maintain management processes, operational procedures and audit programmes including external assessment to ensure effective and efficient compliance with set performance standards and BS ISO 45001.
- Provide information and competent advice to all employees, contractors and supply chain partners on Health, Safety & Wellbeing matters.
- Improve work activities through a regular programme of safety meetings, committees, audits and management safety observations.
- Encourage the reporting of all incidents, near misses, unsafe acts and unsafe conditions and act upon the findings.
